#### Call to Order

President Anderson called the meeting to order at 10:00 a.m. and led the Pledge of Allegiance.

#### **Information Items**

1. 2025-2027 Airport Rates & Fees – Cole Barnes, Airport Manager

Mr. Barnes opened the presentation by providing detail on the Port's hangars and tiedown spaces and outlining the Port's strategic goal of "determining market-based direction for key assets to reduce tax dollar dependency." Commissioner Bozeman shared his overall view that each of the three Port facilities should be breaking even or making a profit which the Airport is not doing at this time.

Mr. Barnes described the previous 3-year cycle procedure for setting rates and tariffs which included CPI increases and the stipulation that rates would be reviewed every three years. A chart was provided showing the large CPI increases over the last three years which were well above the 5% cap placed on 2021-2024 rates.

The result of a recent survey of regional airports was provided which shows Bremerton National Airport (BNA) being a bit below average but it still puts the Port where it needs to be. Most airports in the region are showing rate increases between 5% and 15% with BNA at 8% which keeps the airport current within the region and will help to offset rising construction and maintenance costs.

CEO Rothlin explained the system used in evaluating rates at both the airport and marinas which is a 3-year cycle beginning by using a market rate study to assist in setting rates, then the next 2 years follow CPI. To begin this next 3-year cycle, the market rate study shows rates should be 8% higher than last year. He discussed a letter from a previous airport manager to tenants which led to a misunderstanding of the 5% CPI cap. Due to the misunderstanding, staff would like to provide three options for bringing rates up to market.

- 8% increase April 1, 2025 (January 1, 2026 & 2027 increase using CPI)
- 5% increase April 1, 2025 (January 1, 2026, 2027, and 2028, CPI + 1%)
- 5% increase April 1, 2025 (January 1, 2026, CPI + 3%; January 1, 2027, CPI)

The 2025-2027 Airport Rates & Tariffs is scheduled for adoption at the February 11, 2025, regular commission meeting.

#### Summary:

On January 28, the Port presented an information item to the commission on the proposed Bremerton National Airport 2025 rates and tariffs update. The airport market rate study was last accomplished in 2021. The regular review of airport lease rates is consistent with Port of Bremerton Strategic Plan, Goal #3 "Determine market-based direction for key assets to reduce tax dollar dependency".

Bremerton National Airport has experienced a continued rise in hangar demand, with a long-established waitlist and no vacancies. Operational costs, repairs, and material expenses have steadily increased, and the previous rates have not accommodated these changes.

The proposal for 2025 airport rates incorporates a modest increase in airport lease rates. The proposed airport rates and tariffs update would be consistent with other local airports and remain very competitive within the surrounding region. The proposed airport rates and tariffs update, upon approval, would be scheduled for April 1, 2025, implementation.

#### Fiscal Impact:

Increased 2025 revenue for Bremerton National Airport of \$11,534.00 with CPI increases over the next 2 years

#### **Strategic Purpose:**

Goal 3. Determine market-based direction for key assets to reduce tax dollar dependency. Strategy 3.a. Create, adopt and keep current lines of business Development Plans. Strategy 3.b. Undertake a multi-year analysis to determine viability of operational self-sufficiency.

#### Recommendation:

Staff recommend the approval of the 2025-2027 Airport Rates and Tariffs for Bremerton National Airport as presented.

#### Motion for Consideration:

#### Move to approve:

- The 2025-2027 Airport Rates & Tariffs Schedule for Bremerton National Airport with an effective date of April 1, 2025.
- 3-year cycle: 2025, rate survey and market adjustment; 2026, CPI adjustment; 2027, CPI adjustment; 2028, rate survey and market adjustment.
- Authorization for setting electrical rates to achieve a cost neutral basis.

#### **Summary:**

On December 10, 2024, the Port presented an information item to the commission on the proposed 2025 plaque dedication for former Port Commissioner Larry Stokes at Port Orchard Marina Park.

This dedication serves as a remembrance to the Port Commissioner who was instrumental in creating the Port Orchard Marina Park, tangibly connecting the public visiting our park with the Port's contributions and exemplifies being a strong communicator to the public.
