Executive Session

President Anderson recessed the meeting at 10:02 a.m. and reconvened into executive session at 10:07 a.m. for approximately 15 minutes for the purpose of discussing with legal counsel current or potential litigation [RCW 42.30.110(1)(i)]. At 10:25 a.m. executive session was extended five minutes.

At 10:30 a.m. the regular meeting was reconvened.

Information Items

1. Port Orchard Marina Breakwater Replacement Project Status Update – James Weaver, Director of Marine Facilities

Mr. Weaver introduced Jon Keiser, PND Engineers. Mr. Weaver discussed why this replacement project is so vital to recreational, commercial, emergency services, transit, and tribal moorage. Details of the following were provided:

- Preliminary design
- Project timeline from March 2020 with selection of preferred alternative through December 2025 which is the estimated date for MARAD contract approval and construction bid authorization
- Permitting process
- Scope of work elements and tasks
- Federal MARAD Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant

Mr. Weaver and Mr. Keiser addressed questions and comments from the Board and CEO throughout the presentation.

2. Marinas 10-Year Capital Facilities Update – James Weaver, Director of Marine Facilities

Mr. Weaver explained that Soundwest Engineering Associates (SEA) contracted with the Port in 2023 to update the 10-yr Capital Improvement & Maintenance/Repair Plan for the Port building upon the foundation of the 2017 plan conducted by Art Anderson Associates (AAA).

Marine project costs, priorities, and maintenance costs were evaluated and brought current. The updated plan presents the current anticipated needs and serves as a dynamic guide over the next 10 years. It provides a prioritized database of projects which can be reprioritized based on the availability of grants, the priorities of the Commission, etc. He concluded by stating that this update provides a plan for how the Port can project for that, both revenue-wise and by making sure our P&L's and operational costs incorporate regular assumptions of capital projects.

Mr. Weaver responded to questions and comments from the Board throughout the presentation.

3. Kitsap Economic Development Alliance (KEDA) Briefing on Kitsap Industrial Land, Buildings, and Infrastructure Survey (KILBIS) – Joe Morrison, Executive Director

Mr. Morrison introduced subject matter experts Bryan Lobel and Chris Mefford of Community Attributes, Inc., and provided background on the KILBIS body of work.

Mr. Mefford presented on market opportunities and Mr. Lobel provided full detail on:

- Kitsap County-wide industrial lands inventory
- Priority recommendations for the Port of Bremerton
- Priority recommendations for other local and regional governments

Mr. Morrison provided closing remarks stating this is a unique opportunity and KEDA looks forward to being the Port's partner.

The KEDA team addressed questions and comments from the Board throughout the presentation. There were closing comments from the Port's CEO.
